MINUTES

of the LAKENHEATH PARISH COUNCIL MEETING METHODIST CHAPEL, BACK STREET, LAKENHEATH HELD ON MONDAY 6th November 2023 at 7pm

Mr Garth Tolmie has been assisting the clerk by producing the Lakenheath Parish Council Reports from the new solar Speed Indicator Device.

Generally, people should be on the left hand side of the graphs, but there are more on the right hand side. The graphs show traffic for every day of the week, plus a `heat map`, showing the most likely time and numbers of transgressors. The highest areas of concern are depicted in red.

Mr Tolmie has produced a report for Cllr Kelly showing results for 50+mph. The Police speeding enforcement team seem to operate during office hours.

Looking at the Station Road solar device, because the sun is lower at this time of year, Mr Tolmie recommends that the post is moved to the area a little further up at Woodlands, this would also mean that it is safer to change the battery.

Cllr Kelly thanked Mr Tolmie, LPC are very grateful to Mr Tolmie for his help and interest Cllr Kelly commented that the ANPR scheme run by Suffolk County Council is nothing more than a Speedwatch, results are only followed through if the Police have the resources. The Westcotec ANPR speed cameras are not approved by Suffolk County Council or Police. The officer who runs the ANPR scheme has written a paper to say there is not much difference to a SID. However, there is some good news in that the Mildenhall Area Superintendent agreed that more mobile speeding units will be sent out to our area.

D/Cllr T Whitehand was not present at the meeting. D/Cllr G Kelly reported that the Persimmon site (Eriswell Road) has been given the go ahead at a recent West Suffolk Council meeting. In 2013, Elveden Farms were given `concept to develop` permission. Part of the site is on flood zone 3, and there remains the issue of noise levels from aircraft so close to the Base. This housing is envisaged as starter homes, nevertheless, the MoD are sticking with the 2012 noise profile. In terms of traffic, all of the developments got mixed up; we are already exceeding the projections. LPC needs to make sure Persimmon built to their specifications.

Street lighting LED Grant- Expressions of interest to be submitted prior to the end of January 2024. The RFO will have prior invoice which we can claim. The grant will cover all potential costs.

There may be other schemes in the pipeline that target conservation. Cllr Frost has a meeting with Lacey from Pearce and Kemp.

West Suffolk Council do not specify who carries out the work, as long as it is done professionally and properly. Only Suffolk County Council can offer Tele cells. There are additional conservation schemes available to home owners.

SCC/0041/23FH/FUL

Construction of a new 420-place Primary School and 30-place Pre-School including new access off new road from Station Road and associated development.

Lakenheath Parish Council (LPC) was surprised to learn very recently of this application through conversations, rather than through the formal consultation process. While the Council have joined with and supported the Primary School in development discussions there has been no opportunity to properly consider the application as part of a formal consultation. This is therefore a position statement rather than anything else.

Background

The original application for a new school was part of a conflated scheme of developments in the village, supported by Forest Heath District Council primarily to address a major problem with Land Supply issues. The history of this scheme is well known and it would serve little purpose to rehearse detail, but in essence the regular conflation and unpicking have created less than robust consideration of each element of the scheme. This has resulted in developments which are at best suboptimal and at worst entirely inappropriate. That said, SCC have taken every opportunity to engage with West Suffolk Council (not Mid Suffolk as in the application), LPC, Governors, Staff, Parents from the school and residents.

Finance

SCC have recently announced a £22M funding gap, which raises concerns regarding both the current situation and the future in relation to the school. Current plans must be considered at risk of a damaging watering-down given SCC's need to reduce expenditure.

Traffic

The B1112 single road through Lakenheath carries all forms of traffic including heavy agricultural and commercial vehicles; this road continues to be extremely poorly maintained. The projections in the AECOM traffic study for the multiple developments in the conflated scheme are already exceeded by around 30%. This is hardly surprising with 96% car ownership, which is driven by a lack of local employment, shopping and leisure facilities, with data showing 2.3 cars per working household in the village. It can be assumed that a very high proportion of the permitted and proposed development will be sold to working families, and there is an additional planned 1000 USAF personnel who, while not living in Lakenheath will be using the B1112; this will put an additional 2000 vehicles on the B1112 - at least.

The proposals for dealing with additional traffic arising from the AECOM report do not include any measures north of the Eriswell Rd / Broom Road junction, some 2km from the school. The Parish has provided data on time, volume and speed from the Speed Indicator Display (SID) on Station Rd to both SCC Highways and Education. This regularly shows an 85th percentile speed of just under 35mph. Attempts to get an additional SID to monitor northbound traffic, or better still an ANPR camera have been fraught.

SCC Highways are apparently reluctant to consider physical traffic calming measures due to the mix of traffic on the road, and unlike the very lightly used other junctions on Station Rd,

the school entrance will be heavily used at the start and end of the school day. (The survey conducted by the school among current parents indicated a 150% increase in the number of parents who will use their cars to get children to school).

No provision has been made to allow for the large numbers turning right across traffic either into or out of the school entrance, and Lakenheath Parish Council regard this as a major failure.

Walking /cycling arrangements are still in the early stages of development. LPC is committed to helping arrive at practical routes for those from the East and South of the village. While it appears that there is now provision for cars to turn round once on the service road, LPC believes there has been a serious underestimation of the requirement for drop off / pick up parking. Parents, particularly of the youngest children, simply will not drop off children and expect them to find their own way into school.

Similarly at the end of the day neither the parents nor the school will countenance a queue of children waiting on the pavement. The probable solution for most will be to park on the roads to the south of Station Rd, none of which are designed or capable of safely accommodating large numbers of parked cars. As the Rabbit Hill and Station Rd developments come on stream there may be some opportunities for temporary parking, although it is difficult to see – particularly with Rabbit Hill – how this might work. LPC are committed to providing manpower to assist with traffic management for the first days of the school's opening, but that it is a very short-term expedient.

The school's proposal to have, or at least share, electrically powered minibuses could alleviate many of these issues and LPC will continue to work the school on this; but for this proposal to work at least two of the EV chargers at the school should be capable of charging at least 22kW.

Noise

From the outset LPC have had concerns about the school's location under the flightpath for RAF Lakenheath and the impact of noise on the children's ability to learn. It is good to see that a properly conducted survey has basically confirmed that the arrangements for the buildings themselves appear adequate. There are however concerns that the monitoring period did not appear to include "unrestricted take-offs" where aircraft use afterburners and climb vertically. In these circumstances car alarms are triggered across the village and residents describe the effect as painful. While not an everyday occurrence, these events are more frequent than expected, and the impact not clearly understood. The UKHSA have been asked to consider (specifically military) aircraft noise in the context of noise as a wider determinant of health. Following the number of complaints from residents, the local surgery has also been asked to monitor the nature and extent of reported physical and mental health issues reported as attributable to aircraft noise.

Fundamentally, LPC must insist that the issues around traffic and parking are addressed by the Authority, otherwise we envisage short and long term problems.

Appendix C

On 15 June 2023 at 10:00 the new SID was installed on the B1112 on the pole located on Station Road. The SID was positioned to monitor traffic coming into Lakenheath from Wangford. Traffic speed and counts were measured up until 13:00 of 01 November 2023. The measurement point is 450m past the point where the 30MPH zone starts.

Due to low sunlight conditions and tree cover, the solar panel was not as effective as in the summer months. 9 days of measurements were lost due to the battery going below the operating threshold of 11.8V.

There are between 2900 and 3600 vehicles per weekday passing this point heading into Lakenheath.

There are between 2100 and 2500 vehicles per day over the weekend heading into Lakenheath.

The busiest times during the week are 07:30-08:30 (Avg. 216 cars p/h) and 16:15-17:15 (Avg. 304 cars p/h).


The 85th Percentile Speed (most people) travel at or below 34.9 MPH past his point.

The 50th Percentile Speed (half the traffic) travel at or below 29.1 MPH past his point.

The fastest speed recorded was 90MPH (x3). There were also 438 vehicles exceeding 55MPH.






The solar panel has kept this SID charged throughout this entire period. Battery voltage at time of last measurement was 12.2V.


It takes 3 times the distance to stop at 60MPH as it does to stop at 30 MPH
